The ImagePerfect™ 7700 Styling Films utilise a high-quality PET film with a printed design that, when applied to glass, allows for the easy decoration and customisation of interior windows and partition screens, adding originality, character and sophistication. The eye-catching designs include floral patterns, geometric patterns, wave patterns and vertical and horizontal linear patterns. The designs incorporate a range of solid, graduated and granular effects and they will also add an element of privacy screening in a more subtle fashion than would otherwise be the case if a full blackout film was used. As an exception, rather than a printed PET film, IP 7734 Zurich incorporates a thicker PET film with inherent opalescence and it provides a useful alternative to more typical frosted PVC films for decorative window installations. Another exception is the outstanding design of IP 7735 Boston which imitates fluted glass. In All of the films will be used in corporate and commercial environments, such as meetings rooms, conference facilities and lobbies, as well as retail environments and lifestyle business locations, such as spas, salons, gyms, hotels, theatres and restaurants. The films have high optical qualities. They must be wet applied.

Attention: Do not clean for at least 1 month after application and do not apply any type of sticker or adhesive on the film.
